

CENEX Zip Trip® 2026 Dog Days of Summer Giveaway

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN.

Cenex Zip Trip rewards card/membership account is available and free to join via cenexziptrip.com, in store or via Cenex Zip Trip mobile app. Sponsor has no control over app store download availability. Sponsor reserves the right to disqualify any person who submits more than the maximum allowed entries. Released Parties are not responsible for: lost, late, incomplete, invalid, unintelligible, illegible, misdirected or stolen entries.
